Need for Denominational Change

- Crossroads is currently part of Evangelical Covenant Church
- The church has been in active dissention with ECC over views on Human Sexuality for 10 years.
- Council Members and Committees have been looking into potential denominations during this time.
- Land Sale eliminated ties to ECC through paying off mortgage
- United Church of Christ in line with Crossroads' Value of Inclusion

2023-2024 Financial Results

- Income from Donations, Registration, Facility Rental, etc.
 - \$1,803,135.46
- Expenses Compensation, Building and Grounds, Utilities, Insurance, Purchases, Administration, etc
 - \$2,108,064.36
- Gain on Sale of Water Credits and Interest Income
 - \$239,925.75
- Net Income before Depreciation and Amortization
 - Loss of \$65,003.15
 - Missed Budget before Water Credit Sale by \$19k
 - Changes in Colorado Childcare Assistance Program
- Depreciation and Amortization
 - \$262, 448.96
- Equity through Assets
 - \$4.644.108 based on original purchase prices and depreciation
 - With real estate growth, we estimate that could be doubled

Crossroads' Financial Realities

- \$25k/mo Shortfall
- Choice to stay at 5420 Taft Ave or move elsewhere
- Value of this location for the community, the denomination, etc.
- Already have \$110k in commitments to PIWI 2025
- Looking at additional revenue streams to reduce shortfall

The Ask

Potential Revenue Streams to Offset Deficit

- Leasing Student Center \$90k/yr
- Wedding Business \$36k/yr
- Early Adventures Daycare and Preschool \$24k/yr
- Leasing Space for Latinx Church Services \$7,200/yr
- Church growth \$26k/yr
- Total \$183,200 (more than 50% of current shortfall)
- All of these are in active discussion to happen in the next year or represent attendance trends for Crossroads

2024-2025 Budget Proposal

Proposed Revenue and Expenses

Proposed Budget emailed to members on November 15, 2024

- Income with PIWI Goal (budget revisions could happen with additional revenue streams) - \$2,104,300.57
- Expenses \$2,116,386,37
- Net Income loss of \$12,000 is Partners in Hope Grants paid in September that were part of money raised in June 2024 Gala
- Adventure Center all programming and administration expense for birth to 18 – covered by revenue from Early Adventure Center Daycare and Preschool and Adventure Camps
- Partners in Hope all grants, programming and administration expense paid through fundraising efforts
- Result is a balanced budget
